PROPOSAL

The application to amend the Zoning By-law proposes to redevelop the 2,862.5 square metre property at 1021-1035 Markham Road with a 34-storey mixed use development consisting of 333 apartment residential units and approximately 2,180 square metres of commercial space within the 6-storey podium base building. Parking for 229 vehicles for all uses would be provided on four levels underground. A 269 square meter on-site public parkland dedication is also proposed. The proposed building would have a gross floor area of approximately 26,369.7 square metres, resulting in a net site density, after road widening and parkland dedications, of 10.26 times the net site area.



Zoning By-law Amendment Appeal: If a person or public body does not make oral submissions at a public meeting or make written submissions to the City Clerk, attention: Committee Administrator, Scarborough Community Council, at the address, fax number or e-mail set out in this notice before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision to the Local Planning Appeal Tribunal and may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.
