We would like to request a letter designating the events above as ones with Municipal Significance to obtain Special Occasion Permits from the Alcohol and Gaming Corporation.

As with the past four years, the goal of the events is to promote the neighbourhood feel of the street and drive additional foot traffic to all retail stores, restaurants, salons, and other local businesses in the area.

For each event, we are partnering again with local businesses to set up pop-up booths on Tiger of Sweden's spacious front patio (attached image on the following page), and would like to be licensed to serve food and drinks from local restaurants, and offer services and entertainment to guests and locals who will be enjoying the festivities.

Please note that we have not experienced a high volume of drink consumption in the past, however would like to have the option of sampling alcoholic beverages at the events and require the denotation of municipal significance to receive licensing for the patio.
