Description:

The supply of all materials, equipment, labour and supervision required to complete the playground and water play upgrades at Trace Manes Park including but not limited to playground and splash pad installation, poured-in-place rubber surfacing, new concrete paving and curbs, 'donor wall' installation, and shade structure and site furniture installation, on behalf of the Parks, Forestry and Recreation Division of the City of Toronto.

Loc-Pave Construction Ltd.

Contract Award Value:

\$ 1,751,305 total net of all applicable taxes and charges

\$ 1,978,975 including HST and all applicable charges

\$ 1,782,128 net of HST recoveries

Contract is expected to start following the date of award and end by June 30, 2020.

FINANCIAL IMPACT

The contract award identified in this report is \$1,978,975 including all applicable taxes and charges. The cost to the City is \$1,782,128 net of HST recoveries.

Funding is available in the 2019 Council Approved Capital Budget and 2020-2028 Approved Capital Plan for Parks, Forestry and Recreation as summarized in Table 1.

being within the authority of the Bid Award Panel;

- d. there are no material written objections to the award;
- e. the call document was advertised on the City's internet website and bids or proposals were opened publicly; and

f. the Fair Wage Office confirms the recommended firm understands the Fair Wage Policy and Labour Trades requirements and has agreed to comply fully.
