2019 OPERATING BUDGET BRIEFING NOTE Toronto Parking Authority: Changes to Service and Rent Expenditures

Issue/Background:

At its meeting on February 6, 2019, Budget Committee requested a briefing note from Toronto Parking Authority with an explanation for the 'Service and Rent' expenditure rise, and for why 'Other Expenditures' is currently blank.

The following table provides a breakdown of Toronto Parking Authority's expenditures and revenues by category. This table can also be located on page 14 of the 2019 Budget Notes for Toronto Parking Authority.

Key Points:

- Prior to the 2019 Budget process, the 'Other Expenditures' category solely reflected the cost of municipal taxes incurred by the Toronto Parking Authority. In 2016 and 2017, municipal taxes amounted to approximately \$22.5 million annually. As of the 2018 Q3 Variance Report, municipal taxes were projected to account for approximately \$23.749 million by year-end of 2018.
- The municipal taxes expense item has been re-categorized in the 2019 Staff Recommended Operating Budget for Toronto Parking Authority to more appropriately reflect the costs

associated with 'Service and Rent'. In 2019, municipal taxes will cost the TPA \$24.434 million, which is included in the \$57.026 million identified in the 'Service and Rent' expenditure category.

• The increase in municipal taxes in 2019 is primarily attributable to escalated property assessments by the Municipal Property Assessment Corporation (MPAC).
