2019 OPERATING BUDGET BRIEFING NOTE

Industrial Waste Surcharge Agreement Fee Review

Issue:

• This briefing note responds to Budget Committee's request on February 6, 2019 to provide background information on the Industrial Waste Surcharge policy and previous staff recommendations regarding full cost recovery. The briefing note includes a list of companies releasing more than one treatable parameter, if such information is in keeping with the City's obligations under the Municipal Freedom of Information and Protection and Privacy Act.

Background:

- Urban wastewater is characterized in terms of its physical, chemical and biological constituents that are collectively referred to as "parameters", which are managed through our wastewater treatment plants to protect public health and the environment.
- The concentration of the parameters are governed by Chapter 681 of the Municipal Code, the City's Sewers By-law (the "By-law"), to ensure compatibility with the design and capabilities of our wastewater treatment plants.
- Companies that exceed the wastewater sanitary concentration limits under the By-law for five specific and treatable parameters are given the option of entering into an Industrial Waste Surcharge Agreement ("IWSA") or minimum surcharge permit with the City or installing onsite treatment to comply with the By-law. Most companies opt to enter into an IWSA, as it is generally more cost effective.
- The five treatable parameters permissible under an IWSA and permit are: Biochemical Oxygen Demand (BOD), Total Suspended Solids (TSS), Total Phosphorus (TP), Phenols, and Total Kjeldahl Nitrogen (TKN is a measure of concentrated nitrogen and ammonia); all of which are treatable at Toronto's wastewater treatment plants.
- Under an IWSA, a company's composite sampling data (samples that are generally collected over a 24-hour period) is used to evaluate the quality of wastewater generated by that company for the purpose of recovering a portion of the costs of treating the excess amount discharged over the By-law limit.
- In 2008, the Auditor General's Report on *Protecting Water Quality and Preventing Pollution*, having found that fees for excess treatment were unchanged in Toronto since 1996, recommended that: "The General Manager, Toronto Water, develop a fee policy for all

- surcharge agreements that reflects the cost of sampling and testing and that all companies subject to surcharge agreements be billed on a cost recovery basis."
- In response, Toronto Water retained Stantec Engineering to determine the cost to recover excess treatment fees and to determine if TKN should be added as a surcharge parameter.
- In June 2012, Stantec's report, *Overstrength Surcharge Review for Toronto Water* (the "Stantec Report"), recommended that:
 - new fees for the treatable surcharge parameters cited above, including TKN, be adopted;
 - full cost recovery be established and that Toronto Water charge a company for each surcharge parameter above the By-law limit;
 - an IWSA application fee be introduced on a cost recovery basis, to assess a company's wastewater and prepare the IWSA agreement between the applying company and Toronto Water; and
 - the City review the proposed fees following a two-year period and subsequently in five-year periods going forward.
- City Council at its meeting of November 27-29, 2012 approved the majority of the staff report recommendations that were based on the Stantec Report. Council did not adopt the recommendation to charge companies with IWSA's for each surcharge parameter but rather only the highest surcharge parameter that exceeds the By-law limit. The new fees came into effect on January 1, 2013

- Staff reviewed the fees in 2015, per the Council direction given in 2012 and recommended increases to each surcharge fee under an IWSA. City Council on December 9 and 10, 2015 adopted the staff recommendation to increase all the surcharge fees effective April 1, 2016. The new fees are listed below in Table 1 and continue to apply to only the parameter that exceeds the By-law by the highest amount.

Key Points:

- Currently, companies with IWSA fees are only charged a fee based on the highest surcharge parameter, in excess of the By-law limits, to which an IWSA applies; not all surcharge parameters discharged in excess of the By-law limits that are permitted in their agreements with the City.
- Therefore, the IWSA program is not operating at full cost recovery. The difference between the costs recovered from all active surcharge agreement holders, based on the current surcharge fee structure and the costs incurred by the City for treatment (at full cost recovery) under these IWSA fees is approximately \$1.2 million annually. This loss in revenue is currently being absorbed in the water rates paid by residents and businesses.
- In order to achieve the Audit Committee's recommendation of developing a fee policy based on full cost recovery and to allow companies sufficient time to make changes to processes and budget forecasts, Stantec's report recommended a 5 year phase-in approach using an annual adjustment factor. Table 2 illustrates how using an adjustment factor would incrementally increase the City's current method to a full cost recovery method by 2024.

- Tables 5 and 6 are the lists of 370 companies with active Industrial Waste Surcharge Agreements and Permits with the City of Toronto as of September 30, 2018 and includes the number of surcharge parameters listed on the company's IWSAs and permits based on the most recent Q3 2018 billing date. There were 359 companies with more than one surcharge parameter listed on their IWSA and permit, which would have fees directly impacted should a full cost recovery method to surcharge billing be implemented.
- In order to better assess the impact of the full cost recovery method, the 370 companies were subdivided into 4 categories (minimum fee, low volume, medium volume, and high volume). Table 3 illustrates the impact on 8 specific companies within these four categories from the lowest impacted to the highest impacted. The impact of individual companies varies as

companies with only one surcharge parameter will see the lowest increase while companies with two or more surcharge parameters will see higher increases. Table 4 illustrates the overall average impact for each of the four categories.
