The purpose of this report is to seek further instruction in relation to a development application for a site that contains several heritage resources, and a related ongoing appeal at the Local Planning Appeal Tribunal ("LPAT").

2. City Council authorize the public release of the instructions in Confidential Attachment 1 and Confidential Appendices "A" through "D", if adopted by City Council, with the balance of the Confidential Attachment 1 to remain confidential as it contains advice which is subject to solicitor-client privilege.

DECISION HISTORY

On May 6, 2014, City Council stated its Intention to Designate the property at 10 St. Mary Street.

On March 9, 2017, City Council adopted Item CC26.5 – Request for Direction Report – 10 St. Mary Street – Zoning Amendment Application, accepting a without prejudice settlement offer dated February 28, 2017, that included a direction for the Chief Planner and Executive Director, City Planning to report to the Toronto Preservation Board with recommendations regarding the proposed alterations under the Ontario Heritage Act and the designation of the properties at 718 Yonge Street and 81 St. Nicholas under Part IV of the Ontario Heritage Act.
