Under the Ontario Public Health Standards (OPHS), public health units are required to deliver programs and services under 4 Foundation and 9 Program Standards. Prior to April 1, 2019, the Ministry of Health and Long-Term Care (MOHLTC) provided funding for the programs and services through a cost-shared model (75% provincial/25% municipal) or at 100% provincial funding. In addition to the programs and services delivered under the OPHS, the MOHLTC also provided 100% funding for other programs which are of public health importance.

The Province's 2019 Budget announcements will have a direct impact on a number of the programs in the following table:
