Further, Goldy, who is a self-proclaimed "propaganda arm" for the all-right neo-Nazi movement, supports her political advocacy through ongong donations from supporters. Given the above we have lille confidenca that her income in this time period, much of which comes trom supporters outside Ontario, was kept seperale from campaign donations.

Goldy accepted payments on her campaign website and to a grnail account. Since the candidate is accepting donations by e-franster, we believe their personal bank account should also be captured by a compliance audit to determine whether funds intended lor their campaign are being used as intended and properly recorded seperalely from her income at the time.

I believe on reasonable grounds that the candidate or registered third party noted above has contravened a provision of the Municipal Elections Act, 1996, relating to election campaign finances.
