## EX4.3 - Accelerating the City's Tenants First Project (9.4.19)

Toronto Seniors Forum [TSF] was established by City Council in 2005, to ensure that the Seniors lens and voice is applied to ALL the City of Toronto discussion and decisions.

TSF Members were active contributors on the Accountability Table, authors of the Toronto Seniors Strategy 2.0, which was presented to and accepted by Council [05.18].

### Senior Services and Long Term Care

TSF wholeheartedly endorses Recommendation #1 on page 2 of EX4.3, the creation of the new division which will be named Senior Services and Long Term Care. TSF looks forward to continued dialogue with Councillors and Staff as the division structure develops. And the improved communications within the city structure that it will bring.

Other recommendations within EX4.3 include plans to repair existing housing. TSF asks that you consider keystone issues like the few listed below to be part thought process:

- Any repair or replacement of housing include Universal Design Standards; for example, increasing all door sizes to accommodate wheelchair access.
- That the funding announced last week by the Federal Government, that at the absolute minimum of one-third of the total funding be committed to Seniors Housing.
- Moving forward when approving or discussing any new affordable Housing that at least one-third of all new builds be Seniors focused.
- That within all city-operated housing that infrastructure for on-site Service and Support Providers are included. Consider issues like; Aging In Place or Butterfly Care for People living with Dementia.

# **Engagement with Seniors**

On page 8 of EX4.3, Bullet Point number 4.

While developing the Service Planning model: "Lead Responsibility for engagement with Seniors include liaison with the Toronto Seniors Forum...".

When City Council approved TSS 2.0 last May it included recommendation Number 26, that Councillors hold Seniors Active Living Fairs, TSF will help lead this aspect of TSS 2.0. [When TSS 2.0 was passed, the Councillors absent for the vote were contacted and all but 2 voiced support for the TSS 2.0]. Further:

- TSF has already made progress in advancing that recommendation, and have started to meet with individual Councillors.
- We request that all Councillors respond to the invitations TSF has already extended to meet and discuss the best ways to engage and involve Seniors in their Wards.
- Working toward higher standards of Seniors care and services is not a 5-minute deputation, but an ongoing and continued dialogue. Working together will only provide better ways to discover the needs of the Seniors in your Wards.
