Notice was given and a Public Hearing was held on Thursday, October 11, 2018, as required by the Planning Act.

#### PURPOSE OF THE APPLICATION:

To construct a new detached dwelling with an integral garage and a deck in the rear yard.

#### REQUESTED VARIANCE(S) TO THE ZONING BY-LAW:

### 1. Section 10.20.30.20.(1)(A), By-law 569-2013

The minimum required lot frontage is 15 m.

The new lot frontage will be 9.91 m.

### 2. Section 10.20.30.10.(1)(A), By-law 569-2013

The minimum required lot area is 550 m<sup>2</sup>.

The new lot area will be 377.5 m<sup>2</sup>.

### 3. Section 900.3.10.(5)(A), By-law 569-2013

The minimum required side yard setback is 1.8 m.

The proposed dwelling will be located 1.2 m from the south side lot line and 1.5 m from the north side lot line.

## 4. Section 13.2.6, By-law 7625

The maximum permitted number of storeys is two.

The new dwelling will have three storeys.

#### File numbers B0004/18EYK, A0028/18EYK & A0029/18EYK are considered jointly.
