

Parking Regulation Amendments - Brentwood Road North

SUMMARY

This staff report is about a matter for which the Etobicoke York Community Council has delegated authority from City Council to make a final decision.

Based on a petition received from affected residents on Brentwood Road North, it is recommended that parking be prohibited on both sides of Brentwood Road North between Wilgar Road and Lynngrove Avenue, from 10:00 a.m. and 6:00 p.m., Monday to Friday. This proposed parking prohibition will address the issue of excessive daytime parking on weekdays on this section of Brentwood Road North.

Staff also recommends that the existing "No Parking, 10:00 a.m. to 6:00 p.m. Monday to Saturday" be amended to a "No Parking, 10:00 a.m. to 6:00 p.m., Monday to Friday" regulation on the east side of Brentwood Road North, between Birchview Boulevard and Wilgar Road, to reflect current signage posted on this section of road. In addition, staff recommends that parking be prohibited at all times on the west side of Brentwood Road North, between Wilgar Road and Birchview Boulevard, to reflect current signage on this segment of the street.

RECOMMENDATIONS

The Acting Director, Traffic Management, Transportation Services, recommends that:

1. Etobicoke York Community Council rescind the existing parking prohibition in effect from 10:00 a.m. to 6:00 p.m., Monday to Saturday, on the east side of Brentwood Road North, between Birchview Boulevard and Wilgar Road.
2. Etobicoke York Community Council prohibit parking from 10:00 a.m. to 6:00 p.m., Monday to Friday, on the east side of Brentwood Road North, between Birchview Boulevard and Wilgar Road.

3. Etobicoke York Community Council prohibit parking from 10:00 a.m. to 6:00 p.m., Monday to Friday, on both sides of Brentwood Road North, between Wilgar Road and Lynngrove Avenue.

4. Etobicoke York Community Council prohibit parking at all times on the west side of Brentwood Road North, between Wilgar Road and Birchview Boulevard.

FINANCIAL IMPACT

The estimated cost for signage installation related to the proposed parking regulation amendments is \$1000.00. These funds are available in the Transportation Services 2019 interim Operating Budget.

DECISION HISTORY

This report addresses a new initiative.

COMMENTS

Transportation Services received petitions from residents of Brentwood Road North, between Wilgar Road and Lynngrove Avenue, requesting parking be prohibited from 10:00 a.m. to 6:00 p.m., Monday to Friday, on both sides of Brentwood Road North, between Wilgar Road and Lynngrove Avenue. This proposed parking prohibition is to address the issue of excessive daytime parking on weekdays on this section of Brentwood Road North. The current parking regulations and proposed changes are shown on the area map (Attachment 1).

According to the City of Toronto's Road Classification System, Brentwood Road North is a "local" road located west of Royal York Road, north of Bloor Street West. Brentwood Road North has a lane of traffic in each direction, with a legal speed limit of 40 km/h. There are no sidewalks or curbs on either side of the street north of Birchview Boulevard.

Currently, parking is allowed for a maximum period of three hours on the both sides of Brentwood Road North, between Wilgar Road and Lynngrove Avenue. Current signage on the street indicates that parking is prohibited from 10:00 to 6:00 p.m., Monday to Friday on the east side Brentwood Road North, between Birchview Boulevard and Wilgar Road, although Schedule 13 (No Parking) in Chapter 950 of The Toronto Municipal Code shows that parking is also prohibited on Saturday during the aforementioned time period on the east side of Brentwood Road North between Birchview Boulevard and Wilgar Road. Current signage on the street reveals that parking is prohibited at all times on the west side of Brentwood Road North, between Wilgar Road and Birchview Boulevard North, although there is currently no entry in the aforementioned Schedule 13 related to this section of Brentwood North.

Based on the petitions received, staff recommends that parking be prohibited on both sides of Brentwood Road North between Wilgar Road and Lynngrove Avenue, from 10:00 a.m. and 6:00 p.m., Monday to Friday. This proposed parking prohibition will address the issue of excessive daytime parking on weekdays on this section of Brentwood Road North.

Staff also recommends that the existing "No Parking, 10:00 a.m. to 6:00 p.m. Monday to Saturday" be amended to a "No Parking, 10:00 a.m. to 6:00 p.m., Monday to Friday" regulation on the east side of Brentwood Road North, between Birchview Boulevard and Wilgar Road, to reflect current signage posted on this section of road. In addition, staff recommends that parking be prohibited at all times on the west side of Brentwood Road North, between Wilgar Road and Birchview Boulevard, to reflect current signage on this segment of the street.
