

## **Naming of a Proposed Private Street at 50 Humberwood Boulevard**

**To:** Etobicoke York Community Council

### **SUMMARY**

---

This report recommends that the name "Filly Heights" be approved to identify a proposed private street at 50 Humberwood Boulevard.

Community Councils have delegated authority to decide street naming matters which comply with the City of Toronto Street Naming Policy.

### **RECOMMENDATIONS**

---

Engineering and Construction Services recommends that Etobicoke York Community Council:

1. Approve the name "Filly Heights" for the proposed private street at 50 Humberwood Boulevard.
2. Request the applicant to pay the costs, estimated to be \$500.00, for the fabrication and installation of the street name signage; and
3. Request the owner and successors of the subject lands to maintain, at their own risk, the street name signage installed under Recommendation 2 of the report.

### **FINANCIAL IMPACT**

---

There are no financial implications to the City resulting from the adoption of this report. The estimated cost of \$500.00 for the street name signage is to be paid by the applicant.

## **DECISION HISTORY**

---

This is the first time that this issue is before Community Council.

## **COMMENTS**

---

On December 19, 2018 an application was received from Tribute Communities to name the proposed private street located at 50 Humberwood Boulevard, "Filly Heights", as an acknowledgement to the Woodbine Racetrack which is in close proximity to the site. A filly is a female horse generally under four years of age.

The proposed name has been circulated for comment and is acceptable to Toronto Police Service, Toronto Fire Services, and Toronto Paramedic Services.

There were no objections by Councillor Ford.

The lane is shown as PART 1 on Attachment No.1 Sketch No. PS-2019-026.

This naming proposal complies with the City of Toronto Street Naming Policy.

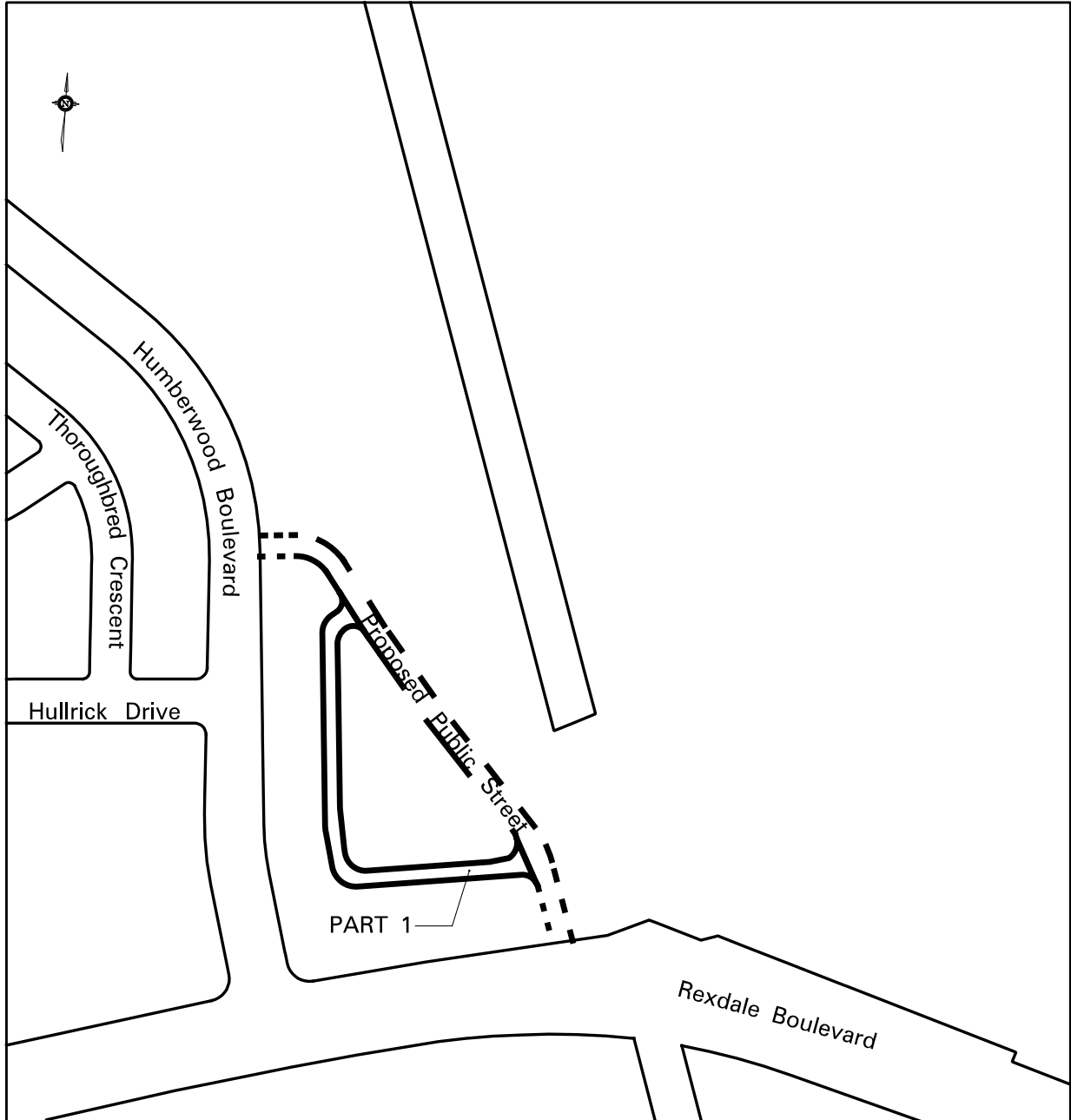
