Feasibility of a New Year's Eve Grace Period for Permit Parking Violations

Notice is hereby given that the General Government and Licensing Committee will be considering the feasibility of a New Year's Eve grace period for permit parking violations.

No specific changes to parking regulations are being recommended at this time.

However, the General Government and Licensing Committee may recommend changes and Toronto City Council may adopt changes to allow for a parking grace period that will eliminate residential permit holders' exclusive access to all permit parking spaces on New Year's Eve.
