RE: GV2.2 Special Committee on Governance Work Plan and Engagement Strategy

Dear Councillor Stephen Holyday, Chair and Members of the Special Committee on Governance.

First, we would congratulate the Special Committee on Governance (SCG) and its staff for an excellent start to the process with the proposed Workplan (Attachment 1), Engagement Strategy (Attachment 2), and the summary analysis of Submissions to date (Attachment 3).

The information submitted to the SCG is critical to its directions. The submissions of Dave Meslin and others have identified a fundamental concern that Toronto has a "democratic deficit", due to a combination of its "single layer" structure and its high "population to representative ratio", when compared with other major cities in North America. This touches at the heart of governance; the relationship between residents and their representative(s), and goes far beyond making sure that the reduction in number of councillors does not result in reduced service. Therefore we believe that the comparative analysis referenced under Theme 1: Supporting Neighbourhoods and Communities Relationships with Local Governance will be very important to understanding how to address the democratic deficit.

Specific suggestions for improvements are as follows:

- A Governance Project Advisory Committee should be established to act as a sounding board for research, ideas, preliminary results, etc. City Planning Division regularly uses this approach for its area studies, with good results.
- An additional Phase between Phase 2 and 3 to allow for development, and public consideration of options and models developed in Phase 2.
- In addition we recommend that at each meeting the SPG should invite presentations
 from outside specialists to inform the discussion, i.e. continue the practice started in
 Committee Meeting #2 (UofT Report). For example the June 2019 meeting might
 have a presentation on Comparative City Governance Models.
