#### SUMMARY

On February 13, 2019, the Local Planning Appeal Tribunal (the "LPAT") issued a decision approving the Zoning By-law Amendment and Official Plan Amendment Applications made pursuant to section 22(7) and 34(11) of the *Planning Act*. The *Local Planning Appeal Tribunal* Act allows the parties to a hearing to seek a review of a decision of the LPAT. The *Local Planning Appeal Tribunal* Act allows the parties to a hearing to seek leave to appeal a decision of the LPAT to the Divisional Court. The information in the Confidential Attachment to this report discusses the LPAT decision and seeks Council's direction regarding a potential appeal and/or review.
