- 2. City Council authorize the public release of the confidential recommendations in Confidential Attachment 1 and Confidential Appendices "A", "B", "C" and "D" to the Report (March 27, 2019) from the City Solicitor, if adopted by City Council.
- 3. City Council direct that the balance of Confidential Attachment 1 to the Report (March 27, 2019) from the City Solicitor remain confidential as it contains advice, which is subject to solicitor-client privilege.

DECISION HISTORY

A Final Report from the Director, Community Planning, Toronto and East York District, dated November 30, 2016 was considered by City Council on January 31, 2017 and in Council Decision Item TE21.1, City Council adopted Official Plan Amendment No. 365 and Official Plan Amendment No. 368 to the City's Official Plan. The City-initiated Official Plan Amendment No's 365 and 368 were appealed to the Ontario Municipal Board, now LPAT, pursuant to section 17 of the *Planning Act*. Notwithstanding recent amendments to the *Planning Act* and their proclamation on April 3, 2018, LPAT will maintain jurisdiction over the appeals. A nine-day hearing on the appeals commenced on March 25, 2019. The City Solicitor requires direction on this matter.
