REASON FOR CONFIDENTIAL INFORMATION

This report concerns litigation or potential litigation that affects the City of Toronto.

SUMMARY

The purpose of this report is to seek further instruction in relation to a development application for a site that contains heritage resources and potential heritage resources, and a related ongoing appeal at the Local Planning Appeal Tribunal ("LPAT").

There was a proposal to amend the Zoning By-law to permit the construction of a 64storey mixed-use building on the development site. Further direction is required in the context of a scheduled LPAT hearing scheduled to commence on January 13, 2020.

RECOMMENDATIONS

The City Solicitor Recommends that:

- 1. City Council adopt the confidential recommendations contained in Confidential Attachment 1.
- 2. City Council authorize the public release of the instructions in Confidential Attachment 1 and Confidential Appendices "A" through "F" if adopted by City Council, Request for Directions 10-16 Wellesley St W, 5-7 St. Nicholas St, and 586 Yonge St
