To consider a proposal to name the proposed private street at 4342 Lawrence Avenue East as "Wildflower Way".

At its meeting to be held in the Council Chamber, Main Floor, Scarborough Civic Centre, 150 Borough Drive, on March 19, 2019 at 9:30 a.m., or shortly afterwards, the Scarborough Community Council will hear in person or by his or her counsel, agent or solicitor, any person who claims that his or her lands will be prejudicially affected by the naming and who applies to be heard with respect to the proposed naming.
