The purpose of the application is to amend former City of Scarborough, Upper-Rouge Hillside Community Zoning By-law Number 25278, as amended, and City of Toronto Zoning By-law Number 569-2013, as amended by adding site specific regulations and land uses to permit an animal shelter, veterinary hospital and wildlife centre including ancillary supportive uses for essential workers for the lands at 6461 Steeles Avenue East.


If you wish to be notified of the decision of the City of Toronto on the passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk, Attention: Carlie Turpin, Administrator, Scarborough Community Council, at the address, fax number or e-mail set out in this notice.

Zoning By-law Amendment(s) Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so. You may submit comments to the City Clerk, Attention: Carlie Turpin, Administrator, Scarborough Community Council, at the address, fax number or e-mail set out in this notice.
