

Extension of Permit Parking Hours – Tecumseth Street

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to extend the overnight on-street permit parking hours on Tecumseth Street, between King Street West and Niagara Street from 12:01 a.m. to 7:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 10:00 a.m., 7 days a week and 5:00 p.m. to 7:00 p.m., Monday to Friday.

By extending the overnight on-street permit parking hours residents will have improved parking flexibility and the Parking Enforcement Unit, Toronto Police Service, can effectively control long term parking by non-residents through tagging and towing operations.

RECOMMENDATIONS

The Manager, Transportation Services, Right of Way Management, Toronto and East York recommends that:

1. Toronto and East York Community Council approve the extension of the overnight on-street permit parking hours on Tecumseth Street, between King Street West and Niagara Street from 12:01 a.m. to 7:00 a.m., 7 days a week to 12:01 a.m. to 10:00 a.m., 7 days a week and 5:00 p.m. to 7:00 p.m., Monday to Friday.

FINANCIAL IMPACT

The amount of \$400.00 is available within the Transportation Services 2019 Interim Operating Budget.

DECISION HISTORY

A request was received from Councillor Mike Layton, on behalf of Tecumseth Street residents, to extend the overnight on-street permit parking hours Tecumseth Street, between King Street West and Niagara Street to address concerns regarding the increase of non-resident parking.

COMMENTS

Tecumseth Street, between Niagara Street and King Street West is a local street operating in a two-way north/southbound direction, on a pavement width of 9.7 metres. There is no TTC Service on Tecumseth Street.

Permit Parking is in place on both sides of the street under the operating hours of 12:00 midnight to 10:00 a.m., 7 days a week. Parking is prohibited on the west side between Niagara Street and Wellington Street West during the times of 8:00 a.m. to 6:00 p.m., Monday to Friday.

Transportation Services has no objections to extending the permit parking hours of operation Tecumseth Street, between King Street West and Niagara Street to improve parking flexibility.
