

## **Realignment of Permit Parking Area 6G to exclude the development located at 1219-231 Dundas Street East**

### **SUMMARY**

---

Transportation Services is requesting approval from City Council to prohibit the General Manager from accepting applications from residents of, visitors to, and tradespersons at the development properties municipally known as 219-231 Dundas Street East for residential on-street permit parking.

Transportation Services has assessed the realignment of permit parking area 6G and the exclusion of the development property located at 219-231 Dundas Street East as requested by Toronto and East York Community Council, Item TE31.6, on April 24, 2019. Transportation Services is recommending approval of the exclusion as it will not impact negatively on Dundas Street East residents.

### **RECOMMENDATIONS**

---

The Manager, Transportation Services, Right of Way Management, Toronto and East York District recommends that:

1. City Council approve the amendment to Schedule B of the City of Toronto Municipal Code, Chapter 925, Permit Parking, to incorporate a revised map of permit parking area "6G", as attached in Appendix A of the report dated January 8, 2019 from the Manager, Right of Way Management, Transportation Services, Toronto and East York District.

### **FINANCIAL IMPACT**

There is no financial impact associated with this report.

## **DECISION HISTORY**

---

At its meeting on April 24, 2018 Toronto and East York Community Council in considering item TE31.6, requested Transportation Services to examine and report back to Toronto and East York Community Council regarding the realignment of permit parking area 6G and the exclusion of the development address of 219-231 Dundas Street East.

## **COMMENTS**

---

The development address of 219-231 Dundas Street East falls within the boundary of permit parking area 6G. Permit Parking area 6G is bounded on the west by Jarvis St, on the north by Gerrard Street East, on the east by Sherbourne Street and on the south by Shuter Street. Area 6G has 117 on-street parking spaces. To date 86 permits have been issued. This area does not have a history of being waitlisted, meaning the demand for overnight on-street parking permits has never exceeded the supply of parking spaces. There is TTC service on Dundas Street East. Councillor Kristyn Wong-Tam and residents neighbouring 219-231 Dundas Street East support this action as a means of ensuring that this new development does not negatively impact the permit parking supply to the existing neighbourhood.

A Public Notice was placed on the City's website requesting those objecting to the exclusion of 219-231 Dundas Street East, from permit parking in area 6G to forward their objections in writing to the City Clerk so they may be scheduled as deputations at the Toronto and East York Community Council meeting. The Clerk has confirmed that no objections have been received.

Transportation Services has no objections to the exclusion of 219-231 Dundas Street East from permit parking in area 6G.
