# REPORT FOR ACTION

Extension of Permit Parking Hours – Hector Avenue, between Davenport Road and Melita Avenue, Rains Avenue, between Davenport Road and Melita Avenue and Melita Avenue, between Rains Avenue and Christie Street

### SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to extend the overnight on-street permit parking hours on Hector Avenue, between Davenport Road and Melita Avenue, Rains Avenue, between Davenport Road and Melita Avenue and Melita Avenue, between Rains Avenue and Christie Street from 12:01 a.m. to 7:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 9:00 a.m., 7 days a week and 4:00 p.m. to 6:00 p.m., Monday to Friday.

By extending the overnight on-street permit parking hours residents will have improved parking flexibility and the Parking Enforcement Unit, Toronto Police Service, can effectively control long term parking by non-residents through tagging and towing operations.

#### RECOMMENDATIONS

The Manager, Permits and Enforcements, Parking recommends that:

1. Toronto and East York Community Council approve the extension of the overnight on-street permit parking hours on Hector Avenue, between Davenport Road and Melita Avenue from 12:01 a.m. to 7:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 9:00 a.m., 7 days a week and 4:00 p.m. to 6:00 p.m., Monday to Friday; and

- 2. Toronto and East York Community Council approve the extension of the overnight on-street permit parking hours on Rains Avenue, between Davenport Road and Melita Avenue from 12:01 a.m. to 7:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 9:00 a.m., 7 days a week and 4:00 p.m. to 6:00 p.m., Monday to Friday; and
- 3. Toronto and East York Community Council approve the extension of the overnight on-street permit parking hours on Melita Avenue, between Rains Avenue and Christie Street from 12:01 a.m. to 7:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 9:00 a.m., 7 days a week and 4:00 p.m. to 6:00 p.m., Monday to Friday.

### FINANCIAL IMPACT

The amount of \$1,200 is available within the Transportation Services 2019 Operating Budget.

#### **DECISION HISTORY**

A request was received from Councillor Josh Matlow, on behalf of area residents, to extend the overnight on-street permit parking hours Hector Avenue, between Davenport Road and Melita Avenue, Rains Avenue, between Davenport Road and Melita Avenue and Melita Avenue, between Rains Ave and Christie Street to address concerns regarding the increase of non-resident parking.

### **COMMENTS**

Hector Avenue, between Daveport Road and Melita Avenue is a local street operating in a two-way north/southbound direction, on a pavement width of 8.5 metres. There is no TTC Service on Hector Avenue.

Parking is prohibited on the east side of Hector Avenue, between Davenport Road and Melita Avenue between the sixteenth day to the last day of each month from April 1 to November 30, inclusive. Parking is prohibited on the west side of Hector Avenue, between Davenport Road and Melita Avenue between the first day to the fifteenth day each month from April 1 to November 30, inclusive. Parking is prohibited at any time from December 1 to March 31 of the following year, inclusive. Permit Parking operates between 12:01 a.m. to 7:00 a.m., 7 days a week, with three hour parking at all other times.

Rains Avenue, between Daveport Road and Melita Avenue is a local street operating in a two-way north/southbound direction, on a pavement width of 8.5 metres. There is no TTC Service on Rains Avenue.

Parking is prohibited on the east side of Rains Avenue, between Davenport Road and Melita Avenue between the sixteenth day to the last day of each month from April 1 to November 30, inclusive. Parking is prohibited on the west side of Rains Avenue, between Davenport Road and Melita Avenue between the first day to the fifteenth day each month from April 1 to November 30, inclusive. Parking is prohibited at any time

from December 1 to March 31 of the following year, inclusive. Permit Parking operates between 12:01 a.m. to 7:00 a.m., 7 days a week, with three hour parking at all other times.

Melita Avenue, between Rains Avenue and Christie Street is a local street operating in a two-way east/westbound direction, on a pavement width of 5.7 metres. There is no TTC Service on Melita Avenue.

Parking is prohibited on the north side of Melita Avenue, between Rains Avenue and Christie STreet between the first and fifteenth day of each month from April 1 to November 30. Parking is prohibited on the south side between the sixteenth day to the last day of each month from April 1 to November 30. Parking is prohibited at any time from December 1 to March 31 of the following year, inclusive. Permit Parking operates between 12:01 a.m. to 7:00 a.m., 7 days a week, with three hour at all other times

Transportation Services has no objections to extending the permit parking hours of operation Hector Avenue, between Davenport Road and Melita Avenue, Rains Avenue, between Davenport Road and Melita Avenue and Melita Avenue, between Rains Avenue and Christie Street to improve parking flexibility.
