

Realignment of Permit Parking Area 7C to exclude the development located at 18-32 Eastern Avenue

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services has assessed the realignment of permit parking area 7C and the exclusion of the development property located at 18-32 Eastern Avenue as requested by City Council, Item CC6.4, on April 16, 2019. Transportation Services is recommending approval of the exclusion as it will not impact negatively on Yorkville Avenue and neighbouring residents.

RECOMMENDATIONS

The Manager, Permits and Enforcement, Parking, Transportation Services recommends that:

1. Toronto and East York Community Council approve the amendment to Schedule B of the City of Toronto Municipal Code, Chapter 925, Permit Parking, to incorporate a revised map of permit parking area "7C", as attached in Appendix A of the report dated June 11, 2019 from the Manager, Permits and Enforcement, Parking, Transportation Services.

FINANCIAL IMPACT

There is no financial impact associated with this report.

DECISION HISTORY

At its meeting April 16, 2019 City Council in considering item CC6.4, requested Transportation Services to examine and report back to Toronto and East York Community Council regarding the realignment of permit parking area 7C and the exclusion of the development addresses of 18-32 Eastern Avenue.

COMMENTS

Permit Parking area 7C is bounded by Parliament Street on the west, by Shuter Street, River Street and Cornwall Street to the north, Bayview Avenue to the east and by Front Street East on the south. Area 7C has 383 on-street parking spaces. To date, 421 permits have been issued. This area does have a history of being waitlisted, meaning the demand for overnight on-street parking permits has exceeded the supply of parking spaces. There is no TTC service on the subject section of Eastern Avenue.

Councillor Kristyn Wong-Tam and residents neighbouring 18-32 Eastern Avenue support this action as a means of ensuring that this new development does not negatively impact the permit parking supply to the existing neighbourhood.

A Public Notice was placed on the City's website requesting those objecting to the exclusion of 18-32 Eastern Avenue from permit parking in area 7C to forward their objections in writing to the City Clerk, so they may be scheduled as deputations at the Toronto and East York Community Council meeting.

Transportation Services has no objections to the exclusion of 18-32 Eastern Avenue from permit parking in area 7C.
