

Extension of Permit Parking Hours – Castle View Avenue

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to extend the overnight on-street permit parking hours on Castle View Avenue, between Spadina Road and Walmer Road, from 2:00 a.m. to 10:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 10:00 a.m., and 6:00 p.m. to 8:00 p.m., 7 days a week and extend the one hour parking maximum to include one hour parking at all other times.

By extending the overnight on-street permit parking hours and introducing one hour parking at all other times, residents will have improved parking flexibility and the Parking Enforcement Unit, Toronto Police Service, can effectively control long term parking by non-residents through tagging and towing operations.

RECOMMENDATIONS

The Manager, Permits and Enforcement, Parking, recommends that:

1. Toronto and East York Community Council approve the extension of the overnight on-street permit parking hours on Castle View Avenue, between Spadina Road and Walmer Road from 2:00 a.m. to 10:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 10:00 a.m., and 6:00 p.m. to 8:00 p.m., 7 days a week.
2. Toronto and East York Community Council amend the existing maximum one hour parking limit in effect from 10:00 a.m. to 6:00 p.m., Monday to Saturday, on the north side of Castle View Avenue, between Spadina Road and Walmer Road, to be in effect from 10:00 a.m. to 6:00 p.m., and from 8:00 p.m. to 12:01 a.m., daily.

FINANCIAL IMPACT

The amount of \$600 is available within the Transportation Services 2019 Operating Budget.

DECISION HISTORY

A request was received from Councillor Josh Matlow, on behalf of area residents, to extend the overnight on-street permit parking hours on Castle View Avenue, to address concerns regarding the increase of non-resident parking during events at Casa Loma.

COMMENTS

Castle View Avenue, between Spadina Road and Walmer Road, is a local street operating in a one-way westbound direction, on a pavement width of 8.2 metres. There is no TTC Service on Castle View Avenue.

Parking is allowed for a one hour maximum between the hours of 10:00 a.m. to 6:00 p.m., Monday to Saturday while Permit Parking operates between 2:00 a.m. to 10:00 a.m., 7 days a week on the north side of the roadway. Parking is prohibited on the south side.

Transportation Services has no objections to extending the permit parking hours of operation and the one hour parking at all other times on Castle View Avenue to improve parking flexibility for residents.
