

## **Reduction of Permit Parking Hours – Pelham Avenue**

### **SUMMARY**

---

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

A request was received by Councillor Ana Bailao to reduce the permit parking hours on Pelham Avenue, between Osler Street, between Osler Street and Uxbridge Avenue from 12:01 a.m. to 9:00 a.m., 7 days a week to 12:01 a.m. to 8:00 a.m., 7 days a week.

### **RECOMMENDATION**

---

The Manager, Permits and Enforcement, Parking and Administration, Transportation Services recommends that:

1. Toronto and East York Community Council approve the reduction of the overnight on-street permit parking hours on Pelham Avenue, between Osler Street and Uxbridge Avenue, from 12:01 a.m. to 9:00 a.m., 7 days a week to 12:01 a.m. to 8:00 a.m., 7 days a week.

The amount of \$100.00 is available within the Transportation Services 2019 Operating Budget.

## **DECISION HISTORY**

---

At its meeting of October 10, 2019, Toronto and East York Community Council in considering item TE9.78 requested Transportation Services to report to report back to Toronto and East York Community Council on the feasibility of reducing the overnight on-street permit parking hours on Pelham Avenue, between Osler Street and Uxbridge Avenue from 12:01 a.m. to 9:00 a.m., 7 days a week to 12:01 a.m. to 8:00 a.m., 7 days a week.

## **COMMENTS**

---

Pelham Avenue, between Osler Street and Uxbridge Avenue is a local street operating in a two-way east/westbound direction. There is no TTC Service on Pelham Avenue. Permit parking is currently in place on the south side of the street under the operating hours of 12:01 a.m. to 9:00 a.m., 7 days a week.

Transportation Services has no objections to reduction of the permit parking hours of operation.
