Purpose of the event

117 indie artists and bands will showcase their original material in front of approx. 8,500 local live music fans and compete for their chance to win the title of The Bout Champion 2019.

An estimated \$30,000 in revenues will be generated for the participating artists through ticket sales, which they keep 100% of.

In addition, a total of \$20,000 in cash prizes will be paid out to the finalists, with the winner taking home \$12,000 cash, \$5,000 in managed marketing and publicity funds generously sponsored by The Herve Basset Foundation, a one year membership to MusicOntario and recording opportunities with Trouble Town Records.

Additional notes & conditions

The Bout Music Festival & Competition agrees to adhere to and abide by the following conditions, which have been outlined by Councillor Mike Layton and the applicable governing bodies.

- This request for extension of hours is for the ground/main floor (indoor) area only, which has a total capacity of 333.
- Security will be doubled for each of the requested dates, with a minimum of six (6) fully licenced security assigned to the front door and sidewalk area. The security will be clearly marked and will wear high visibility jackets.
- Security will undertake to manage smokers and any line up (if applicable) in a professional manner. The focus of this will be to keep the sidewalk free and clear for pedestrians to pass and keep the noise level to a minimum on the street at all times.
