Contract is expected to start on date of award and be completed by December 31, 2021.

FINANCIAL IMPACT

The total contract award identified in this report is \$1,110,092 including all applicable taxes and charges. The total cost to the City is \$999,672 net of HST recoveries.

The engineering estimate for this project is \$1,268,549 net of all taxes and charges.

Funding is included in the 2020 Approved Capital Budget and 2021-2029 Approved Capital Plan for Transportation Services. Funding details are summarized in Table 1 below.
