## Deputation for 2020.IE14.10 - E-Scooters - A Vision Zero Road Safety Approach

Chair Pasternak, Vice-chair McKelvie and Committee members,

Thank you for this opportunity to speak on behalf of Scooty, a Toronto micromobility company, incubated out of Ryerson University's DMZ. We have been participating in the city's study of dockless e-Scooters and we begin by thanking city staff for their hard work and the report they have produced. Scooty started in 2019 because we saw the benefits of micromobility and e-Scooters and wanted to bring these benefits to Toronto. Our Safety, Courtesy, Partnership approach will realize more of the benefits of e-Scooters and address the challenges.

Scooty has demonstrated our commitment to safety by learning from the experiences of hundreds of municipalities that have seen e-Scooters on their roads. Our research has been shared with city staff and with the Ontario Traffic Council. We have extended our commitment to safety by sourcing what we feel is the safest e-Scooter on the market, from a company with decades of experience in low carbon electric micromobility. We even sourced bright yellow helmets to improve rider visibility, and have developed safety training programs and lessons which can be introduced in public schools.

We are very excited about the proposed May 2021 pilot. We know that a six-months or greater city-wide Toronto pilot would see ridership numbers far greater than last year's pilots in Calgary (750,000 trips in three months) and Chicago (800,000 trips in four months). Integrating the pilot with the Transportation Innovation Zone(s), TTC, Bike Share, and the ActiveTO program means we could get better ridership numbers and better quality data. This would improve connections to and between the subway lines, encouraging more local economic activity and supporting communities throughout the city. But rather than waiting for May 2021 and the city wide pilot, we ask the city to consider for this year a series of small, local micropilots tied to Transportation Innovation Zone(s). This will allow all of us to learn and adjust as needed to support and execute a successful e-Scooter rollout program.

We look forward to your supportive vote on the ideas I have put forward, and to meeting with you to demonstrate our safe, top-of-the-range e-Scooter before the Council vote at the end of the month.

Thank you again and I look forward to your questions and feedback.

We have talked with community agencies across various Toronto neighbourhoods about local mobility needs and e-Scooter use plans, and will continue these initiatives under a City of Toronto pilot.
