Exhibition Place Master Plan Update

SUMMARY

At its meeting of February 11, 2020 City Planning staff presented a progress update on the Exhibition Place Master Plan Framework to the Board of Governors relating to (a) the Master Plan Vision and Guiding Principles; (b) the public and stakeholders Consultation Summary; and (c) a Strategy Presentation from City staff. The Board of Governors Decision was a recommendation that City Council direct the City Manager and the Deputy City Manager, Infrastructure and Development Services to report to the Board of Governors of Exhibition Place with an update, when appropriate, on the strategy being developed jointly with the Province of Ontario to plan the future of Ontario Place and Exhibition Place, as set out in part 1 of EX5.1 - Ontario Place/Exhibition Place Revitalization, as it relates to the development of the Exhibition Place Master Plan.

Further, at its meeting of December 19, 2019 City Planning staff presented a progress update on the Exhibition Place Master Plan framework to the Board of Governors. The Board referred the item to the Chief Executive Officer to: a) bring forward to the next Tenant Liaison Consultation meeting to review and obtain input from the tenants; and b) report to the Board with the results at its February 11, 2020 meeting. The Tenant Liaison Consultation meeting was held on January 20, 2020 and a summary of the feedback from this meeting is contained in Attachment 1 to the supplementary report from City Planning. The overview presentation given by City Planning staff at the meeting is contained in Attachment 2.

Further, at its meeting of April 10, 2019, City Planning staff presented the final Cultural Heritage Landscape Assessment (CHLA) for Exhibition Place undertaken by City Planning through the engagement of Archeological Services Inc. Subsequently, a report on this matter entitled "Exhibition Place - Cultural Heritage Landscape Assessment and Next Steps for Master Plan" was presented to City Council and the following recommendations were approved related to the development of a Master Plan for Exhibition Place:

• City Council adopt the proposed Master Plan study framework as described in the report (April 10, 2019) from the Director, Community Planning, Toronto and East York District to guide ongoing work on the Master Plan.

- City Council direct City Planning staff to undertake public consultations on the development of the Master Plan, including consultations with various stakeholder groups, the community at large, and the Indigenous community.
- City Council forward a copy of this Item to the Board of Governors of Exhibition Place for its information and City Council direct City Planning staff to work with the Exhibition Place Board of Governors to coordinate work of the Master Plan with development of the new Strategic Plan for Exhibition Place.

At its meeting of December 19, 2019, City Planning staff gave a presentation to the Board on work completed to date to advance the development of the Exhibition Place Master Plan. The presentation included an overview of the preliminary urban design analysis, draft vision and guiding principles, and ongoing consultation efforts to continue through the end of 2019.

The purpose of the Master Plan is to provide a long-term framework for physical change at Exhibition Place, while recognizing the unique attributes of the site and the role the lands have played in the development of Toronto. The recommended strategies will be informed by the CHLA, the existing planning framework, concurrent transportation and parks initiatives, and consultation input. The Master Plan is intended to be coordinated with the future plans for the revitalization of Ontario Place, and with other initiatives at Exhibition Place including the development of its Strategic Plan.

City Planning staff will be attending the June 24, 2020 Board meeting and will be available to answer questions.

Supplemental updates to the Board will be provided as the progressive phases of the Master Plan is launched.

RECOMMENDATIONS

The Chief Executive Officer recommends that:

(1) The Board of Governors of Exhibition Place receive this report for information.

FINANCIAL IMPACT

There are no negative financial implications of this report.

DECISION HISTORY

The Exhibition Place 2017 – 2019 Strategic Plan has a Recognition and Public Understanding Goal to reaffirm and enhance the profile of the Exhibition Place cultural mandate, and as a Strategy to enhance our archaeological understanding of the site through assessment and development of heritage plans.

COMMENTS

The Exhibition Place lands are located within the boundary of the Downtown and Central Waterfront Secondary Plan (CWSP) which states that development at Exhibition Place is to respect and celebrate Exhibition Place's existing heritage architecture and views of heritage buildings from the water. Adaptive re-use of heritage buildings is encouraged. New development within lands designated Parks and Open Space Areas may only be considered if existing open space areas are maintained or alternatives to expand the size and usability of City-owned parks are provided. The lands are designated as Regeneration Areas and Parks and Open Space Area

Exhibition Place is not regulated by City zoning by-laws but by the City of Toronto Act, 2006. Section 406 of the Act entrusts its management and operations to the Board and outlines the permitted uses, including parks and exhibition purposes, although it also provides for the expansion of uses subject to approval of the City.

In May 2019, City Council directed City Planning to undertake a Master Plan for Exhibition Place under the guidance of the Cultural Heritage Landscape Assessment. City Planning staff formally launched its Master Plan exercise with a Public Open House on June 25, 2019. In this phase of the project, the study team performed a preliminary urban design analysis while undertaking public and stakeholder engagement at various locations throughout the City, including a presentation to the Board of Governors at its meeting of September 19, 2019. Through this first round of consultation, City staff presented the draft vision and guiding principles for the Exhibition Place Master Plan for consideration and feedback.

Planning staff have continued to explore and advance the development of emerging ideas and strategies to realize a potential long-term vision for the Exhibition Place grounds. In addition to its presentation to the Board of Governors on December 19, 2019, and on February 11, 2020, City Planning brought forward directions for input at consultation meetings with Exhibition Place tenants and clients on November 28, 2019 and January 20, 2020; a Local Advisory Committee of area residents' and business organizations on December 2, 2019; a joint meeting of the City of Toronto and Waterfront Toronto Design Review Panels on November 28, 2020; and a public open house on January 13, 2020.

The Master Plan is intended to be coordinated with the Exhibition Place Strategic Plan and will consider opportunities to coordinate with the proposed revitalization of Ontario Place. The supplementary report from City Planning provides details about the proposals and the engagement actions.
