- to support the staff recommendations
- to support accelerating the increase in PFR operating funds to 2020
- to support an increased capital budget
- to recommend other initiatives that would speed up ravine remediation

Why funding is needed

- to clean litter
- to expand what PFR can do to control the growth of invasives
- to support more citizen involvement in ravine stewardship program
- to combat erosion and invest in park infrastructure

Why MORE funding is needed

- to expand capital spending to include more than the first ten priority areas
- to expand what PFR can do to control the growth of invasives
- to support more citizen involvement in ravine stewardship programs

Citizens can help!

contribute labour, time, expertise



Impediments to citizen help

- excessive concerns about City liability
- lack of effective protocols for citizen work on public land
- insufficient staff to supervise and inform citizen work
- lack of City certification standards to enable citizen expertise to be used

Why PRIVATE funding is needed

- to expand what the City can do
- we need private support for park assets in the ravines
- but we also need private funding that can lever what PFR's operating budget can do
- we need private-public partnerships to bring ravine land-owners into invasive species control

Utilize subsidy programs

- Other govt levels provide subsidies for stewardship
- Let's use them!
- No cost to City, other than cost of publicizing availability

Impediments to private funding

- we applaud the Round Table initiative
- but this is primarily oriented to funding park assets
- private funding can also contribute to non-capital funding — invasives control, education, private landowner initiatives
- Need protocols for work on public lands

Recommendations, requests

- 1. Support proposed funding increase, operating increase in 2020, capital funding in 2021
- 2. Request staff report on additional funds required to meet acceptable standard of invasives control in all Toronto ravines
- 3. Request staff to report on potential training and certification programs to utilize citizen expertise.

Requests (continued)

- 4. Request staff to report on workable private-public operating partnerships
- Amend recommendation 8 in staff report to require reporting on progress once each Council term.
- Request that first progress report include estimated cost of expanding capital program to include next ten priority areas
