## RE: Declaring a Climate Emergency and Accelerating Toronto's Climate Action Plan

I am writing to request OMERS assistance on a very important environmental, social and investment governance matter.

Toronto Council has been very busy in 2019 implementing its critical climate action plan: from our TransformTO initiative; to evaluating whether Toronto should disclose its climate-related financial risks through its annual financial statements; and possible amendments to our Statement of Investments and Procedures to exclude fossil fuels from our investment portfolio and undertake active investments in clean tech.

As expert investors of our pension assets, it would help us to know OMERS approach to managing global warming risk in its investment activities. Particularly, how, as fiduciaries, you go about managing the demands of doing things that will help solve climate change challenges while ensuring good returns for OMERS beneficiaries.

I am requesting that a member of your board's investment committee and OMERS Chief Investment Officer, Satish Rai, consider attending our General Government and Licensing Committee in the very near future and offer us a brief overview of OMERS investment governance framework and how both the board and management coordinate the varied mandates of your many assets to ensure sustainable growth of our pension plan. If attendance is an issue, please consider sending written materials to the committee that spell out your framework for climate-related investing and governance.
