Request to Amend the Zoning By-law Application No. 19 114174 NNY 06 OZ Draft Plan of Subdivision Application No. 19 232756 NNY 06 SB

PROPOSAL

The purpose of this City-initiated Zoning By-law Amendment and Draft Plan of Subdivision is to facilitate a mixed-use development, including affordable rental housing, a new public street and new public parkland on the City-owned property at 50 Wilson Heights Boulevard. Development of the property is being advanced as part of the City's Housing Now initiative.

This property is currently used as a commuter parking facility for Wilson Subway Station and for a Toronto Transit Commission bus driveway. The proposed Zoning By-law Amendment will permit up to 129,175 square metres of development across four development blocks comprising residential units, indoor and outdoor amenity space, office, childcare, community and retail space. Development will include five buildings, with maximum building heights ranging from approximately four storeys to 16 storeys. Two levels of underground parking are proposed including commuter parking spaces. The Zoning By-law Amendment will include performance standards related to the location, scale and massing of the new buildings. Redevelopment of the site in accordance with the Zoning By-law Amendment and Draft Plan of Subdivision will result in the provision of a new public park (0.75 acre) and a new public street connecting the site to Wilson Heights Boulevard. The Zoning By-law Amendment will facilitate the development of approximately 1,500 dwelling units.



Zoning By-law Amendment Appeal and Draft Plan of Subdivision Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment and Draft Plan of Subdivision are passed or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the



Local Planning Appeal Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so. You may submit comments to the City Clerk, Attention: Nancy Martins, Administrator, Planning and Housing Committee, at the address, fax number or e-mail set out in this notice.

People writing or making presentations at the public meeting: The *City of Toronto Act, 2006*, the *Planning Act*, and the City of Toronto Municipal Code authorize the City of Toronto to collect any personal information in your communication or presentation to City Council or its committees.
