PROPOSAL - PURPOSE AND EFFECT

The City of Toronto is currently undertaking a review of the Official Plan which was adopted by Council in 2002 and came into effect in 2006. A copy of the current Official Plan can be viewed or downloaded from the City's website: <https://www.toronto.ca/city-government/planning-development/official-plan-guidelines/>. The *Planning Act* requires that an Official Plan be reviewed at least every five years.

In 2014, City Council adopted OPA 274 covering the areas of: (1) the Integration of Transportation Planning with Land Use Planning; (2) Streets and "Complete Streets"; (3) Active Transportation; (4) Auto, Transportation Demand Management (TDM) and Parking; and, (5) Goods Movement. This left several areas of transportation policy outstanding, namely: (1) transit, (2) cycling, and (3) street map and schedules. Since 2014, the areas of automated vehicles and shared mobility have emerged as new areas with possible policy interest.

In 2018, City Council directed City Planning to undertake further review of the set of transportation policies related to: (1) transit, (2) cycling, (3) automated vehicles and shared mobility, and (4) street related map and schedules. During the review, staff also identified possible amendments to policies related to the transportation of water, wastewater and stormwater. This review is now complete and the City of Toronto is proposing an amendment to the Official Plan which would amend portions of Sections 2.1, 2.2, 2.2.2, 2.4, Map 3, Map 4, Map 5, Schedule 1 and Schedule 2; add a new Section between existing Sections 3.1.1 and 3.1.2, and; amend portions of Chapter 6, No. 5 Scarborough Centre Secondary Plan.

The proposed Official Plan Amendment has been developed with input from an extensive public consultation, including with the public, stakeholders, adjacent municipalities and Provincial ministry and agency staff. As part of the City of Toronto's Five Year Official Plan Review, this Official Plan Amendment will be in conformity with the Growth Plan for the Greater Golden Horseshoe (2017), will be consistent with the Provincial Policy Statement (2014) and has regard to matters of provincial interest under Section 2 of the *Planning Act*. The Official Plan Amendment will be submitted to the Minister of Municipal Affairs and Housing for approval pursuant to Section 26 of the *Planning Act*.

The *Planning Act* requires that a Special Public Meeting must be held on any proposed amendments to the Official Plan and that an Open House be held if the Official Plan is being amended to ensure that the public has an opportunity to review and ask questions about the information and material made available in advance of the Special Public Meeting. The holding of public hearings on the Official Plan Amendment may be delegated by Council to the Planning and Housing Committee under Section 24 of the *City of Toronto Act, 2006* and the *Toronto Municipal Code*.

DESCRIPTION OF SUBJECT LANDS

The proposed Official Plan Amendment will apply to the area generally contained within the City of Toronto.

BACKGROUND INFORMATION

At its April 2019 meeting, City Council adopted a staff report titled "Official Plan Review: Draft Transportation Policies for Consultation". At that meeting, City Council directed staff to undertake public and stakeholder consultation, including public open houses, stakeholder meetings and other public meetings as necessary, on the proposed update to the Official Plan transportation policies. Staff were directed to report back with a final report and a recommended Official Plan Amendment on the set of transportation policies related to: Transit, Cycling, Automated Vehicles and Shared Mobility, and Street related Map and Schedules at a Planning and Housing Committee meeting.
