## Re: 2020.PH17.4, Creating New Supportive Housing Opportunities in Parkdale

I am writing on behalf of United Way Greater Toronto (UWGT) in support of this motion before you. Your adoption of this motion will help propel further momentum on the Social Medicine Initiative(SMI), which UWGT is a signatory of, along with the University Heath Network (UHN) and the City of Toronto. UWGT community partners like PARC and St Stephen's Community House (The Neighbourhood Group) are key players as well. While SMI was conceived and signed before COVID-19 outbreak, its mission and purpose have been amplified by the pandemic. The time has come to double down on a proactive approach in reducing the development of new health issues before they arise by trying to addressing root social causes and needs to such unignorable issues as homelessness.

UWGT has heard consistently and clearly from front-line funded agencies in communities across the GTA: without safe, secure housing, people too often remain trapped in a cycle of poverty. COVID-19 has revealed the inequity that exists in our region– home to great prosperity, and yet a place where too many struggle to find shelter. By coming together across sectors — health, community services, shelter providers and housing providers – and bringing forward voices from the community, we can take an integrated approach to provide real solutions to homelessness.
