

Realignment of Permit Parking Area 6N to exclude the development located at 373 Front Street East and 90 Mill Street

SUMMARY

Transportation Services is requesting approval from City Council to prohibit the General Manager from accepting applications from residents of, visitors to, and tradespersons at the development property municipally known as 373 Front Street East and 90 Mill Street for residential on-street permit parking.

Transportation Services has assessed the realignment of permit parking area 6N and the exclusion of the development property located at 373 Front Street East and 90 Mill Street as requested by Toronto and East York Community Council, Item TE10.25, on November 5, 2019. Transportation Services is recommending approval of the exclusion as it will not impact negatively on Front Street East and Mill Street residents.

RECOMMENDATIONS

The Manager, Permits and Enforcement, Parking, Transportation Services recommends that:

1. City Council approve the amendment to Schedule B of the City of Toronto Municipal Code, Chapter 925, Permit Parking, to incorporate a revised map of permit parking area "6N", as attached in Attachment A of the report dated December 12, 2019 from the Manager, Permits and Enforcement, Parking, Transportation Services.

FINANCIAL IMPACT

There is no financial impact associated with this report.

DECISION HISTORY

At its meeting November 5, 2019 Toronto and East York Community Council in considering item TE10.25, requested Transportation Services to examine and report back to Toronto and East York Community Council regarding the realignment of permit parking area 6N to exclude the development at 373 Front Street East and 90 Mill Street.

COMMENTS

Permit Parking area 6N is bounded by Parliament Street on the west, Front Street East to the north as well as the GO Train tracks to the south and east. Area 6N has 47 permit spaces. To date, 51 permits have been issued. This area does have a history of being waitlisted, meaning the demand for overnight on-street parking permits has exceeded the supply of parking spaces. There is TTC service Front Street East and no TTC service on Mill Street.

As required under the City of Toronto Municipal Code, Chapter 925, Permit Parking, the General Manager requested the City Clerk to provide Notice. A Public Notice was placed on the City's website requesting those objecting to the exclusion of 373 Front Street East and 90 Mill Street from permit parking area "6N" to forward their objections in writing to the City Clerk, so they may be scheduled as deputations at the Toronto and East York Community Council meeting.

Transportation Services has no objections to the exclusion of the development located at 373 Front Street East and 90 Mill Street from permit parking area 6N.
