

Introduction of Overnight On-Street Permit Parking – Rose Park Drive

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to introduce overnight on-street permit parking on Rose Park Drive, between Mount Pleasant Road and Welland Avenue, on a street name basis, under the operating hours of 12:01 a.m. to 7:00 a.m., seven days a week.

Area residents requested the implementation of overnight on-street permit parking on Rose Park Drive, between Mount Pleasant Road and Welland Avenue to accommodate their long term parking needs without being subject to tagging by Parking Enforcement Officers.

RECOMMENDATIONS

The Manager, Permits and Enforcement, Parking, Transportation Services
Recommends that Toronto and East York Community Council:

1. Approve the amendment of Schedule A of City of Toronto Municipal Code, Chapter 925, Permit Parking, to incorporate the north side of Rose Park Drive, between Mount Pleasant Road and Welland Avenue, on a street name basis, under the operating hours of 12:01 a.m. to 7:00 a.m., seven days a week.
2. Prohibit parking at all times on the south side of Rose Park Drive, between Mount Pleasant Road and Welland Avenue

FINANCIAL IMPACT

The amount of \$550.00 is available within the Transportation Services 2019 Operating Budget.

DECISION HISTORY

A request was received from Councillor Mike Layton, on behalf of area residents, to introduce the overnight on-street permit parking program on Rose Park Drive, to accommodate their long term parking needs.

COMMENTS

Rose Park Drive, between Mount Pleasant Road and Welland Avenue, is a local roadway operating in a two-way north/southbound direction with a pavement width of 8.53 metres. There is no TTC service on Rose Park Drive.

Currently parking is permitted for a maximum 3-hour duration on the both sides of the street. As only the north side of the street has a sidewalk, Transportation Services is recommending affixing parking to the north side only as a means ensuring traffic flow and pedestrian safety.

Under the provisions of Municipal Code, Chapter 925, Permit Parking, we are required to conduct a poll of the residents to determine if there is support to introduce permit parking.

Ballots were mailed on January 20, 2020, with the last day for filing a response being February 18, 2020. The results of the poll are as follows:

The majority of area residents returned their ballots in favour of the introduction of overnight on-street permit parking on Rose Park Drive, between Mount Pleasant Road and Welland Avenue.

Transportation Services has no objections to the implementation of permit parking on Rose Park Drive, between Mount Pleasant Road and Welland Avenue.
