

Extension of Permit Parking Hours – Shaw Street

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to extend the overnight on-street permit parking hours on Shaw Street, between Essex Street and Bloor Street West, from 12:01 a.m. to 7:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 7:00 a.m., and 5:00 p.m. to 7:00 p.m., 7 days a week with a one hour maximum parking duration from 8:00 a.m. to 5:00 p.m., 7 days a week.

By extending the overnight on-street permit parking hours and introducing one hour parking, residents will have improved parking flexibility and the Parking Enforcement Unit, Toronto Police Service, can effectively control long term parking by non-residents through tagging and towing operations.

RECOMMENDATIONS

The Manager, Permits and Enforcement, Parking, recommends that:

1. Toronto and East York Community Council approve the extension of the overnight on-street permit parking hours on Shaw Street, between Essex Street and Bloor Street West from 12:01 a.m. to 7:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 7:00 a.m., and 5:00 p.m. to 7:00 p.m., 7 days a week.
2. Toronto and East York Community Council authorize parking for a maximum period of one-hour from 8:00 a.m. to 5:00 p.m., 7 days a week, on the west side of Shaw Street, between Bloor Street West and Essex Street.

FINANCIAL IMPACT

The amount of \$700 is available within the Transportation Services 2020 Operating Budget.

DECISION HISTORY

A request was received from Councillor Mike Layton requesting the General Manager, Transportation Services to the Toronto and East York Community Council on the extension of the overnight on-street permit parking hours on Shaw Street, between Essex Street and Bloor Street West along with an implementation of a maximum 1 hour parking maximum from 8:00 a.m. to 5:00 p.m.

COMMENTS

Shaw Street, between Essex Street and Bloor Street West, is a local street operating in a one-way southbound direction, on a pavement width of 7.3 metres. There is no TTC Service on Shaw Street.

Permit Parking operates between the hours of 12:01 a.m. and 7:00 a.m., 7 days a week on the west side of the roadway. Otherwise parking is allowed for a maximum period of three hours. On the east side of the roadway there is No Stopping Anytime.

Transportation Services has no objections to extending the permit parking hours of operation and the one hour parking from 8:00 a.m. to 5:00 p.m. on Shaw Street between Essex Street and Bloor Street West to improve parking flexibility for residents.
