Extension of Permit Parking Hours – Booth Avenue

SUMMARY

This staff report is about a matter which Community Council has delegated authority from City Council to make a final decision.

Transportation Services is requesting approval from Toronto and East York Community Council to extend the overnight on-street permit parking hours on Booth Avenue, between Queen Street East and Eastern Avenue, from 12:01 a.m. to 7:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 7:00 a.m., and 4:00 p.m. to 6:00 p.m., 7 days a week.

By extending the overnight on-street permit parking hours, residents will have improved parking flexibility and the Parking Enforcement Unit, Toronto Police Service, can effectively control long term parking by non-residents through tagging and towing operations.

RECOMMENDATIONS

The Manager, Permits and Enforcement, Parking and Administration, recommends that:

1. Toronto and East York Community Council approve the extension of the overnight on-street permit parking hours on Booth Avenue, between Queen Street East and Eastern Avenue from 12:01 a.m. to 7:00 a.m., 7 days a week to the new hours of 12:01 a.m. to 7:00 a.m., and 4:00 p.m. to 6:00 p.m., 7 days a week.

FINANCIAL IMPACT

The amount of \$700 is available within the Transportation Services 2020 Operating Budget.

DECISION HISTORY

A request was received from Councillor Paula Fletcher, on behalf of area residents,

to extend of the overnight on-street permit parking hours on Booth Avenue, between Queen Street East and Eastern Avenue.

COMMENTS

Booth Avenue, between Queen Street East and Eastern Avenue, is a local street operating in a one-way southbound direction, on a pavement width of 6.4 metres. There is no TTC Service on Booth Avenue.

Permit Parking operates between the hours of 12:01 a.m. and 7:00 a.m., 7 days a week on the west side of the roadway. The parking regulations for Booth Avenue are as follows:

East side:

No parking anytime, between Eastern Avenue and Booth Avenue

West side:

- No parking, 7:30 a.m. to 6:00 p.m., Monday to Friday between Louis Kesten Lane and a point 22 metres south of Queen Street East;
- No parking, 7:30 a.m. to 6:00 p.m., Monday to Saturday between Eastern Avenue and Louis Kesten Lane
- No parking, 6:00 p.m. to 7:30 a.m. Monday to Friday, Anytime Saturday and Sunday, between a point 22 metres south of Queen Street East and the first lane south of Queen Street East.
- No parking anytime, between Queen Street East and a point 22 metres south
- 15 minute parking, 7:30 a.m. to 6:00 p.m., Monday to Friday, between a point 22 metres south of Queen Streets east and the first lane south of Queen Street East
- One-hour parking, 8:00 a.m. to 6:00 p.m., Monday to Saturday between Eastern Avenue and the first lane south of Queen Street East

Transportation Services has no objections to extending the permit parking hours on Booth Avenue between Queen Street East and Eastern Avenue.
