

## **Car-share Vehicle Parking Areas – Emily Street and Bastion Street**

### **SUMMARY**

---

This staff report is about a matter for which Community Council has delegated authority from City Council to make a final decision, provided that it is not amended so that it varies with City policy or by-laws.

Transportation Services is requesting authorization to rescind car-share vehicle parking areas (CVPAs) on Emily Street and on Bastion Street.

### **RECOMMENDATIONS**

---

The Acting Director, Traffic Management, Transportation Services, recommends that:

1. Toronto and East York Community Council rescind the car-share vehicle parking area for up to two Maven vehicles on the east side of Emily Street, between a point 31 metres north of Wellington Street West and a point 11 metres further north.
2. Toronto and East York Community Council prohibit parking at all times on the east side of Emily Street, between a point 31 metres north of Wellington Street West and a point 11 metres further north.
3. Toronto and East York Community Council rescind the car-share vehicle parking area for up to two Maven vehicles on the east side of Bastion Street, between a point 16.7 metres south of Sloping Sky Mews and a point 11 metres further south.

4. Toronto and East York Community Council prohibit parking at all times on the east side of Bastion Street, between a point 16.7 metres south of Sloping Sky Mews and a point 11 metres further south.

## **FINANCIAL IMPACT**

---

All costs associated with the necessary signage installation are included within the Transportation Services 2020 Operating Budget.

## **DECISION HISTORY**

---

At its meeting of September 16, 2019, Toronto and East York Community Council authorized the installation of car-share vehicle parking areas (CVPAs) for Maven car sharing company on Emily Street and Bastion Street (Item TE8.39).

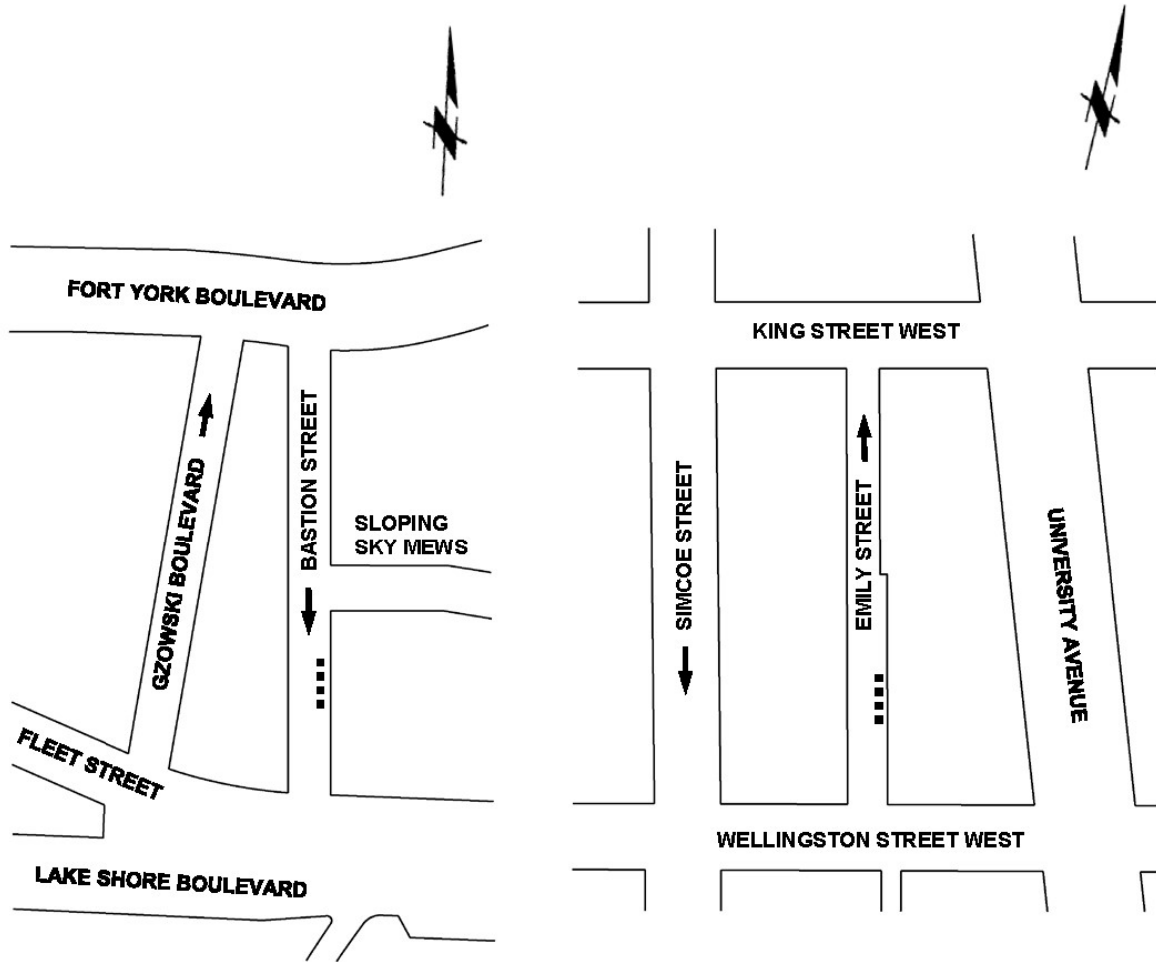
