

## **Introduction of Overnight On-Street Permit Parking – Streets in Wards 4, 9 and 14 – Non-Delegated**

**Date:** August 20, 2020  
**To:** Toronto and East York Community Council

**Wards:** Ward 4, 9 and 14

### **SUMMARY**

---

Transportation Services is requesting approval from City Council to introduce overnight on-street permit parking on the streets listed in attachment A, on an area name basis, under the operating hours of 12:01 a.m. to 7:00 a.m., 7 days a week.

The implementation of overnight on-street permit parking is a means to accommodate residents long term parking needs without being subject to tagging by Parking Enforcement Officers.

A companion report "Introduction of Overnight On-Street Permit Parking – Streets in Ward 4, 9 and 14" outlines streets for locations without TTC Service.

### **RECOMMENDATIONS**

---

The Manager, Permits and Enforcement, Parking, recommends that:

1. City Council approve the amendment of Schedule A of City of Toronto Municipal Code, Chapter 925, Permit Parking, to incorporate the streets listed in attachment A of the report dated August 20, 2020, on an area name basis, within newly created areas, under the operating hours of 12:01 a.m. to 7:00 a.m., 7 days a week.

### **FINANCIAL IMPACT**

---

The amount of \$4,000 is available within the Transportation Services 2020 Operating Budget.

## **DECISION HISTORY**

---

A request was received from Toronto and East York Community Council requesting the Director of Transportation Services, Toronto and York District, in consultation with the City Solicitor, to report to the Toronto and East York Community Council on the potential policy changes and/or by-law amendments that would authorize Residential On-street Permit Parking on streets that currently do not have permit parking in the Toronto and East York District. A response to Toronto and East York Community Council's request was provided at its meeting of April 4, 2017, however the committee deferred Transportation Services' report to the May 2, 2017 meeting. The Committee Decision can be found at:

At its meeting of May 2, 2017, Toronto and East York Community Council requested the Director of Transportation Services, Toronto and East York District, to provide additional information on the potential for policy changes and/or by-law amendments to allow for the implementation of the Residential On-street Permit Parking Program on streets that do not currently have permit parking in the Toronto and East York District.

The specific recommendations were to report on:

- a. list of the streets, that currently do not have Permit Parking, but could accommodate on-street parking;
- b. a proposed consultation plan including the option of a Special Meeting of Toronto and East York Community Council;
- c. more detailed cost and staffing implications for consideration prior to the 2018 budget process;
- d. proposed by-law amendments that do not require polling and petitions; and
- e. an implementation plan.

At its meeting of October 17, 2017, Toronto and East York Community Council, requested the Director of Transportation Services, Toronto and East York District to develop and implement a public consultation plan on the proposal to implement Residential On-street Permit Parking on streets that do not have permit parking in the Toronto and East York District. Additionally, Transportation Services were asked to undertake on-street parking field surveys to calculate the number of potential parking spaces that can be added to the current permit parking inventory from streets that fall within the (former) boundary of the Toronto and East York District that currently do not have permit parking.

At its meeting of January 15, 2019, Toronto and East York Community Council, requested that Transportation Services bring forward recommendations and implementation timelines for the "Expansion of the Residential On-Street Permit Parking Program" report to the March 19, 2019 meeting of the Toronto and East York Community Council.

At its meeting on June 25, 2019, Toronto and East York Community Council requested Transportation Services to review and report back to Toronto and East York Community Council on:

- a. the proposed area boundaries for on-street permit parking in wards 4,9 and 14;
- b. the feasibility of polling all streets in Ward 19 which are located within an existing permit parking area, but do not currently have permit parking; and
- c. the list of local streets in Wards 10,11 and 13 that may be converted to Permit Parking and, in consultation with the Ward Councillor, with recommendations for comprehensive neighbourhood traffic and parking changes where appropriate.

At its meeting January 29, 2020 City Council approved Alternate Recommendation 2:

City Council exempt the implementation of permit parking on the streets listed in Attachment B to the report (November 26, 2019) from the Director, Permits and Enforcement, Transportation Services, from the requirements of subsection 925-4B of City of Toronto Municipal Code Chapter 925, Permit Parking, including both the petition and polling requirement, until such time as Toronto and East York Community Council considers a request for implementation of permit parking at that location.

## **COMMENTS**

---

Transportation Services has assessed the streets in attachment A, determined the feasibility of implementing on-street permit parking. Transportation Services will install permit parking signage on the streets listed in Attachment A over a phase in-period of 18 months. Prior to the installation of the signage, a review of current parking regulations will be conducted for each street listed to ensure public safety and traffic flow. Residents will be notified by letter three weeks prior to the installation of permit parking signage in order to provide them with notice of the change in parking regulations and sufficient time to obtain a parking permit.

Transportation Services has no objections to the implementation of permit parking on the above noted residential streets within wards 4, 9 and 14.
