

Refusal of a Clothing Drop Box Location permit application located at 19 Dorval Road.

SUMMARY

The purpose of this staff report is to report on the refusal to issue a permit by Municipal Licensing & Standards in the matter of an application for a Clothing Drop Box Location permit at 19 Dorval Road.

RECOMMENDATIONS

The Director of Business Licensing and Regulatory Services, Municipal Licensing & Standards recommends that:

1. City Council deny the application for the proposed Clothing Drop Box Location permit at 19 Dorval Road.

FINANCIAL IMPACT

There are no financial implications resulting from the adoption of this report.

DECISION HISTORY

This is a new application for a clothing drop box permit located at 19 Dorval Road.

COMMENTS

An application for clothing drop box permit privileges at 19 Dorval Road was received on March 4, 2020 from the business owner representing 2399390 Ontario Ltd. operating as Green Earth Textiles. The application submitted was seeking permission to place/install at the subject location. (Appendix No. 1 and 2)

This application meets the physical criteria for a clothing drop box location permit, as set out in Chapter 395 of the City of Toronto Municipal Code.

The City of Toronto Municipal Code, Chapter 395-2, Subsection B.(1)(a) states: Where a written objection is received by the Executive Director within the fourteen day period in Subsection B(1)(a), the Executive Director shall refuse the application, notify the applicant of the refusal of the application and advise the applicant that the applicant may, within 30 days of the date of the refusal, appeal the refusal to the Executive Director in writing.

An objection from the Ward Councillor was received by Municipal Licensing & Standards on March 5, 2020.

A refusal letter was sent on March 5, 2020 to the business owner, advising the applicant that an objection was received and that the clothing drop box location permit application was denied.

On March 10, 2020 a letter was received by Municipal Licensing & Standards from the business owner, to appeal the decision of the denial for a clothing drop box location permit.

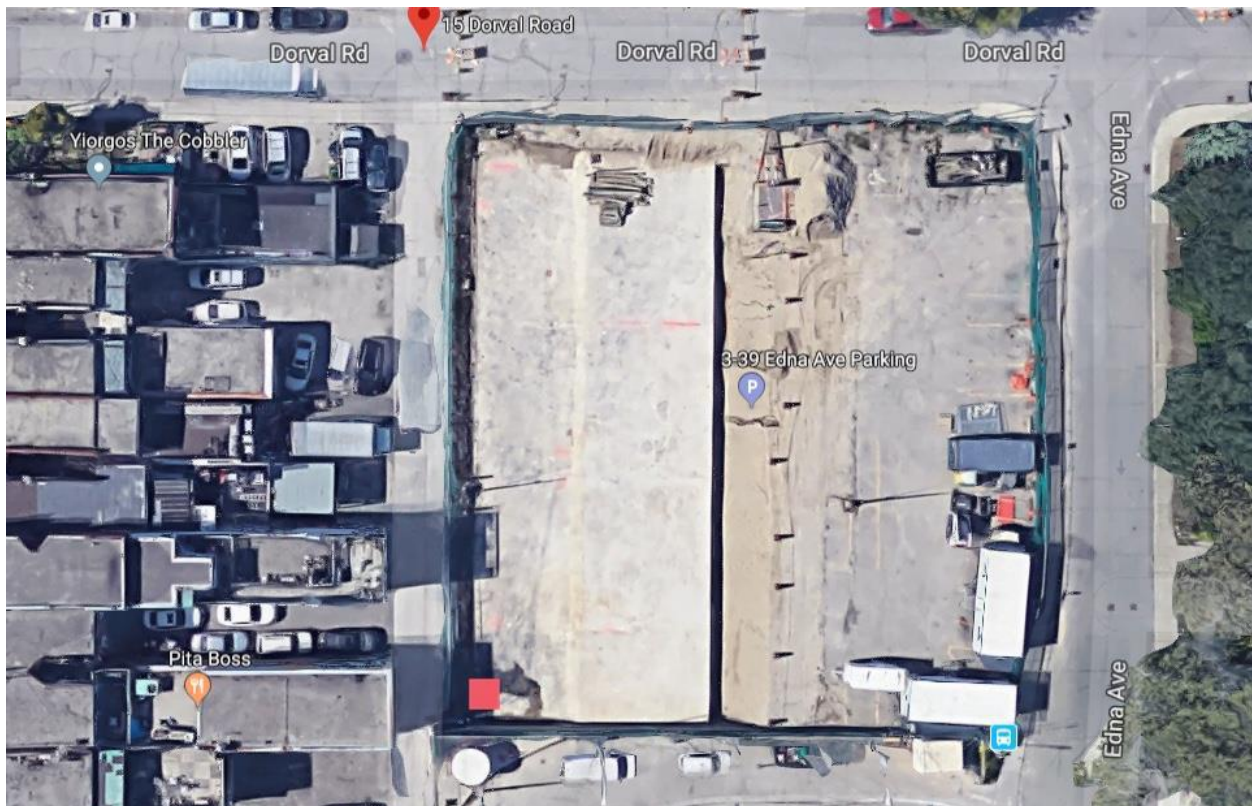
