Description:

To provide all labour, equipment, materials and supervision for the replacement of the refrigeration system equipment, concrete pad and associated outdoor lighting, on behalf of the Parks, Forestry & Recreation Division of the City of Toronto.

Recommended Supplier:

Joe Pace & Sons Contracting Inc.

Contract Award Value:

\$1,836,300 net of all applicable taxes and charges
\$2,075,019 including HST and all applicable charges
\$1,868,619 net of HST recoveries

The contract is expected to start following the date of award and end by January, 2022.

FINANCIAL IMPACT

The total contract award identified in this report is \$2,075,019 including all applicable taxes and charges. The total cost to the City is \$1,868,619 net of HST recoveries.

The engineering estimate for this project is \$1,587,900 net of all taxes and charges

Funding for this project is included in the 2021 Council Approved Capital Budget and 2022-2030 Capital Plan for Parks, Forestry, and Recreation as summarized in Table 1 below.
