FINANCIAL IMPACT

The contract award identified in this report is \$586,524 including all applicable taxes and charges. The cost to the City is \$528,183 net of HST recoveries.

The engineering estimate for this project is \$570,176 net of all taxes and charges.

Funding is included in the 2021 Approved Operating and Capital Budgets for Transportation Services, Funding details are provided in Table 1 below.
