On June 26, 2018, City Council directed the City Solicitor and City Staff to attend the Local Planning Appeal Tribunal to oppose the applicant's appeal respecting the Official Plan Amendment and Zoning By-law Amendment for 245-285 Queen Street East, 348-410 Richmond Street East, 88-106 Ontario Street and 8-12 Brigden Place.
