Toronto Parking Authority executed an agreement (the Agreement) to sell the lands municipally known as 20 Castlefield Avenue and 565 Duplex Avenue (the City Lands) to 2500 Yonge Street Limited (the Purchaser). The City of Toronto did not approve the sale of the City Lands as provided for in the Agreement.
