Re: IE26.6 Actions to Reaffirm Toronto's Tree Canopy Target

December 13, 2021

Dear Mayor John Tory and Members of City Council,

The ABC Residents Association is a volunteer organization committed to enhancing the quality of life in our neighbourhood through active participation in municipal issues. We serve the residents living in Toronto's Yorkville/North Midtown community between Yonge Street west to Avenue Road and Bloor Street north to the CPR tracks.

We are writing to express support for IEC's recommendation that City Council reaffirm Toronto's target of 40% tree canopy cover by 2050 to align with the City's TransformTO Net Zero strategy and as a means for Toronto to address the ever more pressing issue of climate change.

It comes as no surprise that the Tree Canopy Study undertaken in 2018 determined that the biggest potential for tree canopy growth is provided by Toronto's Neighbourhoods. However, we believe that the 40% tree canopy target will not be achieved without actually protecting private trees of protected size, strengthening existing tree protection by-laws, increasing enforcement of the by-laws, and maintaining and enhancing soft landscaping requirements in the zoning bylaws.

Therefore, we respectfully ask that:

- More smaller trees, which are not protected if development is as-of-right, be protected by decreasing the minimum size for protected trees from ≥30 cm to >15 to fall in line with neighbouring municipalities such as Oakville and Mississauga, which protect trees >15 cm.
- 2) Permissions to injure or destroy healthy trees where development is as-of-right be removed from the Municipal Code Chapter 813, given that most properties can be redeveloped around existing trees.
- 3) The required replacement planting ratio be increased from 1:1 to 1:3 when private, healthy trees are removed regardless of size.
- 4) The protection for soft landscaping in the Zoning Bylaws be maintained or enhanced.
- 5) The reduction of the soft landscaping requirement in the Laneway Suites by-law be opposed, particularly given that laneway suites are largely being constructed in Toronto's Neighbourhoods, which the 2018 Tree Canopy Study has identified as the largest potential for tree canopy growth.
