- 4. Attachments T1-T9 showed that the candidate had more than two flyers printed. The flyers and signs were printed or made by Toronto Printing Co. Ltd. The candidate made three payments for the flyers:
 - (A) \$5000 deposits on December 12, 2020 (Attachment T19, Invoice #36567); How the candidate paid this remained unknown: By Cheque #6? By Cheque #10? Or by Cheque #14?
 - (B) \$3996.81 by Cheque #8, on December 28, 2020 (Attachment T18, Invoice # 36566);
 - (C) \$4440.90 BY Cheque #12, on Jan. 1, 2021 (Attachment T21, Invoice # 36568);
 - (D) During the pandemic, all the flyers were mailed out by Canada Post. There were only two mailing costs disclosed, \$7074.00 (Attachment T14, Invoice #36562) and \$7074.00 (Attachment T20, Invoice #36567); Missing one payment for mailing cost of \$7074.00.



5. The candidate altered or forged at least one of the invoices of Toronto Printing Co. Ltd. The invoices (Attachment T12-T28) did not show the fax number 416-609-9931 or 905-752-0530 as before (Attachments T29-T34). The Invoice # 36567 (Attachment T19) dated 12/21/2020, indicated a deposit of \$5000 on 12 Dec 2020 paid. How can the invoice predict a date of future payment? *Balace \$2993.62 31 Dec 2020 Paid. Clearly this invoice was altered or forged. Forgery is a criminal offense. This is another issue with the criminal court.

6. Attachments T72-T74 showed that there were nine receipts marked as Petty Cash. Were they paid from the campaign account? By cheque #6, by cheque #10 or by cheque #14? Unknown.
