PROPOSAL

The applicant proposes to amend the Zoning By-law to permit a 13 storey building containing 190 dwelling units, with retail units on the ground floor for the property at 2839 Jane Street. The 13th floor contains no residential units and is only for rooftop amenity space. The development would consist of 14,049 square metres of gross floor area, representing 3.83 times the lot area. The proposed development would be 42.2 metres in height (including the mechanical penthouse and rooftop amenity area). Parking is proposed to be provided in 250 spaces, of which 40 are for visitors and 17 are for commercial use.

Zoning By-law Amendment Appeal: If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused, the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so.
