# Naming of two Proposed Private Streets at 225 Birmingham Street

# SUMMARY

This report recommends that the names "Lloyd Janes Lane" and "William Jackson Way" be approved to identify two proposed private streets at 225 Birmingham Street.

# RECOMMENDATIONS

Engineering and Construction Services recommends that Etobicoke York Community Council:

- 1. Approve the name "Lloyd Janes Lane" for a proposed private street at 225 Birmingham Street shown as PART 1 on Attachment No.1 Sketch No. PS- 2020-022.
- Approve the name "William Jackson Way" for a proposed private street at 225 Birmingham Street shown as PART 2 on Attachment No.1 Sketch No. PS- 2020-022.
- 3. Request the applicant to pay the costs, estimated to be \$1000.00, for the fabrication and installation of the street name signage; and
- 4. Request the owner and successors of the subject lands to maintain, at their own risk, the street name signage installed under Recommendations 1 and 2 of the report.

# FINANCIAL IMPACT

There are no financial implications to the City resulting from the adoption of this report. The estimated cost of \$1000.00 for the street name signage is to be paid by the applicant.

# **DECISION HISTORY**

This is the first time that this issue is before Community Council.

#### COMMENTS

An application was received on December 18, 2019, from a developer, via the Ward Councillor's office to name two proposed private streets at 225 Birmingham Street in honour of two prominent local-area community figures.

The following background and rationale provided by the Ward Councillor's office:

#### "Lloyd Janes Lane"

"District Chief Lloyd Janes was killed in the Line of Duty on Dec. 4, 1978 at Kimberly Clark Paper Co. when huge rolls of paper soaked with sprinkler water crushed him during a structural collapse."

Consent was provided by the son of the named party.

#### "William Jackson Way"

"Honoring a past New Toronto Mayor who was in office from in 1929 to 1951. He served as the Reeve of Etobicoke from 1919-1920" and also donated land for a Public Library Building.

William Jackson died of a sudden heart attack on November 24, 1951, shortly after returning home from a nomination meeting in which he was acclaimed mayor for the ninth successive year".

Consent was provided by the grandson of the named party.

The Proposed Private Streets are shown as PART 1 and Part 2 respectively on Attachment No.1 Sketch No. PS- 2020-022.

The proposed names have been circulated for comment and are acceptable to Toronto Police Service, Toronto Fire Services, and Toronto Paramedic Services.

Councillor Mark Grimes, Ward 3 Etobicoke-Lakeshore, supports this naming.

Community Councils have delegated authority to decide street naming matters which comply with the City of Toronto Street Naming Policy.
