## **PROPOSAL**

This application proposes to amend the former City of York Zoning By-law 1-83 and City-wide Zoning By-law 569-2013 to permit a 24-storey mixed use building with 254 residential units, including 15 rental replacement units, and 466 square metres of retail space. A related Rental Housing Demolition and Conversion application (File No. 20 171964 WET 05 RH) for 1693 and 1705-1707 Weston Road has been submitted and will be considered at the same time.


**If you wish to be notified** of the decision of the City of Toronto on the passing or refusal of the proposed Zoning By-law Amendment, you must make a written request to the City Clerk attention: Nancy Martins, Administrator, Etobicoke York Community Council, at the address, fax number or e-mail set out in this notice.

**Zoning By-law Amendment Appeal:** If a person or public body would otherwise have an ability to appeal the decision of the Council of the City of Toronto to the Local Planning Appeal Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the City of Toronto before the proposed Zoning By-law Amendment is passed or refused the person or public body is not entitled to appeal the decision and may not be added as a party to the hearing of an appeal before the Local Planning Appeal Tribunal unless, in the opinion of the Tribunal there are reasonable grounds to do so.

You may submit comments to the City Clerk, attention: Nancy Martins, Administrator, Etobicoke York Community Council, at the address, fax number or e-mail set out in this notice.
